a. To open and run, educational and vocational schools or institutions to bring education within the reach of poor & backward children, in the National Capital Territory of Delhi.


b. To provide libraries, publish books on educational, cultural & social subjects, organize discussions & seminars to impart knowledge & understanding amongst the people.
